I am able to provide an **Annotated Victims of Crime Assistance Act 1976** with a commentary as at the 30<sup>th</sup> October 2022.

The annotations relate to Tasmanian and interstate decisions and the commentary relates to the workings of the Act, with some useful information on making, arguing and presenting an application for compensation in accordance with the Act.

The text is aimed at those working for legal aid, community legal groups and legal practitioners requiring an understanding of victims of crime systems and the nature type and bases of compensation payable in Tasmania.

Recent changes to the Act and Regulations are incorporated into the text and include details of increases in compensation and information about the maximums payable for victims of crime.

The text is produced with the assistance of the Tasmania Law Foundation.
